Approximately 12" H x 4" W x 4" D, suitable for display as an award
4. Media: Free standing sculpture/mixed media
5. Material restrictions and considerations:

Sharp or pointed elements shall not be included unless incorporated in such manner as to prevent injury to the public. Artwork must be constructed of durable materials that can withstand some amount of handling by award recipients. Materials shall be sourced from re-used/re-purposed items related to activities conducted in commercial buildings and/or for everyday use.

All materials are subject to County approval. All fabrication/installation products and methods shall be submitted for County review and approval prior to fabrication as soon as possible upon execution of the Contract of Artwork.

It is not necessary that all pieces of artwork be uniform; however, they must be consistent in quality of materials, durability, size and shape.
